"Echoes of Suffering: Women's Resilience Needs Attention Under Taliban Cruelty"

Introduction: In the aftermath of the Taliban's return to power in Afghanistan on August 15, 2021, following two decades of U.S. occupation, the region has witnessed a tumultuous period marked by political turmoil, ethnic tensions, and the resurgence of extremist groups. The two preceding decades were dominated by the leadership of two incompetent figures, Hamid Karzai and Ashraf Ghani, whose divisive policies exacerbated ethnic conflicts and weakened the nation's institutions. The power struggle within the puppet regimes, fuelled by ethnic rivalries and external influences, ultimately paved the way for the Taliban's resurgence.

Since then, when the Taliban assumed power following 20 years of American occupation under the pretext of counterterrorism efforts, Afghanistan has undergone a tumultuous transformation. The preceding two decades witnessed the installation of two ostensibly incompetent figures, Hamid Karzai and Ashraf Ghani, who pursued a divisive "divide and rule" policycontributing to the chaotic situation in Afghanistan, their governance fuelled ethnic conflicts, purged experienced personnel from key governmental roles, and replaced them with inexperienced individuals from abroad. These recruits, largely of Afghan descent from Western countries, lacked a genuine understanding of Afghanistan and were appointed based on personal connections and ethnic considerations.

During the puppet governments' tenure, power struggles and conspiracies among various ethnic groups took precedence over addressing the country's challenges. The Taliban, favoured for their ethnic affiliation with the Pashtun group, received substantial financial and logistical support, including terror training facilities. These developments culminated in the orchestrated release of Taliban members from prisons, a move facilitated by Zalmay Khalilzad, the US special envoy for Afghanistan. However, Khalilzad's actions have been widely

perceived as manipulative and biased, with many blaming him for providing false information to American decision-makers.

Despite assurances of amnesty for former government employees, the reality on the ground has been grim. Over the past two years, individuals associated with the previous military, civil service, parliament, women's rights, arts, music, education, and healthcare have been systematically targeted, resulting in killings, maiming, imprisonment, and assassinations under the Taliban's rule. This reign of terror persists due to ongoing financial and logistical support from the USA, its allies, and Pakistan. Furthermore, the Taliban's influence is expanding as they garner support from various countries, including Iran, India, Russia, and China. This geopolitical scenario places the USA in a challenging position, contending with regional power dynamics involving key Asian rivals vying for influence over the Taliban.

Consequently, the people of Afghanistan endure immense hardships, marked by poverty, insecurity, and the brutalities of the Taliban. Women, in particular, face severe restrictions akin to being confined in a Labor detention camp. The responsibility for this dire situation rests heavily on the USA, and even casual observers can recognize that the Afghan population is subjected to inhumane conditions imposed by a group that many view as terrorists, some of whom are listed by the UN.

In conclusion we are witness, Afghanistan grapples with the consequences of a swift and chaotic regime change, the impact on its people is profound. The promises of amnesty and inclusion made by the Taliban remain unfulfilled, with targeted attacks on various sectors of society, including military, civil, artistic, and academic circles. The plight of Afghan women, confined within a regime that denies them basic rights, underscores the urgent need for international attention and intervention. The complexity of this situation extends beyond national borders, involving geopolitical rivalries and the role of external actors, notably the United States and its regional competitors. In navigating the path ahead, the fate of Afghanistan hangs in the balance, shaped by the interplay of historical dynamics, global interests, and the resilience of its people.
